

#### CHOICE OF THE HEATSINK

The user must choose according to the working conditions of the component (power, room temperature). Maximum working temperature must not exceed 150 °C. The dissipated power is simply calculated by the following ratio:

$$P = \frac{\Delta T}{R_{TH (j - c)} + R_{TH (c - h)} + R_{TH (h - a)}} (1)$$

P: Expressed in W

 $\Delta T$ : Difference between maximum working temperature and room temperature

R<sub>TH (j - c)</sub>: Thermal resistance value measured between resistive layer and outer side of the resistor. It is the thermal resistance of the component.

Example:

R<sub>TH (c - a)</sub> for LTO 30 power rating 10 W at ambient temperature +25 °C

Thermal resistance R<sub>TH (i - c)</sub>: 4.2 °C/W

Considering equation <sup>(1)</sup> we have:

ΔT = 150 °C - 25 °C = 125 °C  $\begin{array}{l} R_{TH \ (j \ - \ c)} + R_{TH \ (c \ - \ h)} + R_{TH \ (h \ - \ a)} = \frac{\Delta T}{P} \ = \ \frac{125}{10} \ = \ 12.5 \ ^{\circ}C/W \\ R_{TH \ (c \ - \ h)} \quad R_{TH \ (h \ - \ a)} = \ 12.5 \ ^{\circ}C/W \ - \ 4.2 \ ^{\circ}C/W \ = \ 8.3 \ ^{\circ}C/W \end{array}$ 

with a thermal grease  $R_{TH (c-h)} = 1 \text{ °C/W}$ , we need a heatsink with  $R_{TH (h-a)} = 7.3 \text{ °C/W}$ .




In any case the applied voltage must be lower than the maximum overload voltage of 750 V.

### ENERGY CURVE




#### **POWER CURVE**


